CG 6690 PC ADVISED FOLLOWING GIANCANA'S FIRST APPEARANCE BEFORE *FOURTH GRAND JURY* EGG, NEW YORK CITY DURING EARLY PART OF YEAR, MEETING HELD IN CHICAGO TO DECIDE WHO WOULD HANDLE CHICAGO HOODLUM AFFAIRS SHOULD GIANCANA GO TO JAIL. MOST LOGICAL HOODLUMS MENTIONED ARE SAM BATTAGLIA AND FIORE BUCCIERI, HOWEVER, DUE TO REPORTED RIFT BETWEEN BUCCIERI AND BATTAGLIA, CHICAGO HOODLUMS FELT FACTIONAL DISPUTE MIGHT ARISE. U

ACCORDING TO SOURCE, CHARLES ENGLISH REPORTEDLY WAS DECIDED UPON SINCE ENGLISH SUPPOSEDLY ACCEPTABLE TO BOTH PARTIES. U
