JACOBSON's remarks again concern the fact that a surreptitious meeting between D'ARCO and GIANCANA was interrupted by Chicago Agents during the mid-afternoon of 11/29/62. It is noted that a very brief and vague mention indicating that somebody from the First Ward Organization was intending to meet with GIANCANA during the afternoon of 11/29/62, was furnished during the late morning of 11/29/62, by CG 6576-C\*. Due to the fact that CG 6498-PCI had very recently advised that he met with GIANCANA at the Czech Lodge in North Riverside, Illinois, it was felt by Chicago Agents that possibly the meeting between the representative of the First Ward and GIANCANA would also take place there, it being noted that this PCI is an apolitician. Based on this information, SAs RALPH R. HILL, WILLIAM F. ROEMER, and MARSHALL E. RUTLAND proceeded to the Czech Lodge at approximately 1:00 p.m. on 11/29/62, and observed a car known to be frequently utilized by GIANCANA in the parking lot of the restaurant. Feeling that little could be lost in the way of jeopardizing either CG 6576-C\* or CG 6498-PCI, the Agents decided that more could be gained by physically interrupting the conference of GIANCANA with the representative of the First Ward meeting with him. When the Agents first went into the restaurant, they were unable to locate GIANCANA and his conferee but later from information furnished by the bartender there, SA ROEMER determined that they were meeting in a private dining space. He, therefore, went into the private area, greeted GIANCANA with reference to his nickname "MOE" and shook hands with D'ARCO, it being noted that D'ARCO has been interviewed on several occasions by SA ROEMER. It is noted that D'ARCO pretended

Our confidential techniques and sources in Chicago are disclosing the almost complete influence and control of politicians, police and even courts in the Chicago area by the underworld. Giancana and his hoodlum associates stay clear of Federal violations in our jurisdiction. Our Agents are contacting and interviewing these hoodlums and their associates, playing one against the other with the objectives of causing disruption, developing informants and causing mistakes on which we can capitalize. We are disseminating information of local violations where we can find a trustworthy local official. We are again sending to the Attorney General a memorandum highlighting this corruption and enclosed a detailed report which can be utilized in Grand Jury hearings to begin in [redacted]. During Grand Jury hearings we will endeavor to develop (1) Federal violations, (2) local violations, and failing these will explore whether [redacted]
