Sources have previously reported that subject was operating the Deauville Casino, Havana, Cuba, and as of 9/9/58, a source reported that subject's wife said subject had a 75% in the Deauville.

HAV 4 (protect) advised in July, 1958, the Hotel Deauville Casino maintained a bank account with the Banco Continental Cubano, and that the casino was organized as the "Casino de Malecon y Galiano, S.A.," with an authorized capital stock of \$100,000. Officers were listed as FRANCISCO FLORES RODRIGUEZ, President; HENRY RUBINO, Treasurer; RAFAEL MORALES MONTALVO, Secretary.

HENRY RUBINO formerly resided Apt. 5B, Calle 12, #20, Vedado, Havana, which was the same apartment building in which subject resided while in Havana. Sources reported RUBINO was to be an interest holder with subject in the Deauville Casino, however, a source reported there had been a falling out between subject and RUBINO, and RUBINO returned to Miami, Fla., his home.
