Information Regarding SAMUEL A. RIZZO and CLYDE C. PACK

Previous investigation has reflected that CLYDE C. PACK, a local contractor numbered among his associates. STEFANO ANTHONY RANDAZZO, La Cosa Nostra member, and PACK also was noted to be on the Board of Directors of the Palm Springs General Hospital, Hialeah, Florida, of which OAKLEY G. SMITH, TRAFFICANTE attorney, is president. PACK is also noted to be handling part of the construction for the new country club, Two Seasons, Inc., owned by SAMUEL A. RIZZO.

The records of the Miami Office of the FBI reflect that SAMUEL A. RIZZO, also known as SAM RIZZO, was born September 19, 1916. In 1952, RIZZO came to Miami from the New York area and was involved in the construction and building industry. By 1960, he had a net worth of \$2,500,000, with an annual salary of \$27,000, and an income and profits of \$200,000. In April, 1960, RIZZO sold all of his Florida interests to invest in Berkshire Downs Race Track, Hancock, Massachusetts. Sometime thereafter, and prior to his return to Miami in about 1965, RIZZO was alleged to have been managing or was the owner of the Carosel, a gambling casino in Las Vegas, Nevada, where he was alleged to have been operating this casino for Teamsters Union interests. He is currently president of the Two Seasons, Inc, 20820 NE 12th Avenue, North Miami Beach, Florida. Two Seasons, Inc., is currently building the Skylake Country Club, located at 750 NE 195th Street, North Miami Beach, Florida. The prime contractor for this construction is Pack Construction Company, 7700 NW 74th Avenue, Medley, Florida.
