Re Chicago letter to the Bureau dated 12/24/58 and Bureau routing slip dated 1/15/59.

Information contained in referenced letter and photographs of subject and his wife were furnished to Chief Inspector JOHN PEARCE, Metropolitan Police, New Scotland Yard, London, England, on January 23, 1959. On January 30, 1959, Chief Inspector PEARCE advised that there was no record of GUS ALEX or MARIANNE ALEX in the Central Records Office of New Scotland Yard. There was a record, however, indicating that GUS and MARIANNE ALEX left London Airport on December 22, 1958, for Zurich, Switzerland, which indicates that these people did visit the United Kingdom. No other information was available concerning them.

It is suggested that in future cases of this type this office be advised as expeditiously as possible concerning travel plans of individuals planning to visit the United Kingdom. If this office can be advised prior to the arrival of such individuals, a more complete and thorough investigation can be undertaken by our sources which would include Customs search, surveillances, etc.
