Reference Chicago letter, 12/24/58, forwarded with Bureau routine slip, 1/15/59.

The following information regarding the subject's activities in Vienna, Austria, was furnished under date of 2/5/59 by Mr. JOSEF HOLAUBEK, Police President, Vienna, and received on 2/9/59.

GUS ALEX, born 1/4/14, in Chicago, American citizen, and his wife, MARIANNE RYAN ALEX, arrived in Vienna, Austria, on 1/6/59 and registered in the Hotel Imperial at 16 Kaerntnerring, Vienna I, Austria. ALEX was carrying United States passport #730.270 good until 7/12/59. Upon arrival at the hotel, he listed his permanent address as 9353 South Spaulding Avenue, Evergreen Park, Illinois, USA. His double room at the hotel had been reserved by the Drake Travel Service through the "Cosmos" travel service in Vienna.

Personnel at the Hotel Imperial were shown photographs of the subject and his wife and were able to readily identify these photographs. They, however, could not furnish any information indicating any unusual activities on the part of either the subject or his wife while they remained at the hotel. The couple appeared to engage in the usual sight-seeing and shopping activities in Vienna and there was no information that they had received any guests at the hotel. Both on 1/8 and on 1/9, the subject placed telephone calls to the Hotel "Baur" in Zurich, Switzerland.

The subject and his wife departed Vienna on 1/9/59 for an undisclosed destination.
