On 2/23/71 CS MEX 287 advised that subject continues to reside in his apartment in Mexico City. Reportedly, PHYLLIS MC GUIRE visited him in Mexico City in January, probably the week of 1/18/71. In addition, he was reported to have taken a short vacation at Cozumel, Mexico.

Reportedly, his house in Cuernavaca is for sale.

Subject appears to be in very good health. He is wearing a full beard and occasionally wears a mod-style wig which he claims to have obtained in Beirut, Lebanon. There are rumors that he has traveled to the Near East and has an apartment or the use of an apartment in Beirut.

On 2/17/71 subject's name came up in a general discussion with JULIO CERECEDO, Chief of Mexican Immigration at the Mexico City International Airport. Comment was made that subject apparently enters and leaves Mexico with ease although reportedly having been circulated on the Mexican lookout list. It was speculated that he might use private flights for such. Mr. CERECEDO advised that he would re-enforce stops at the Mexico City Airport with particular attention to the separate terminal being utilized for private flights.

On 3/15/71 WILLIAM G. BEINERT of the IRS, American Embassy, Mexico City, advised that he had confirmed through his sources in Cuernavaca that
