ReRomelet 1/28/63 and Bern let to Bureau 3/6/63 which requested the Rome Office to ascertain the subscriber of Athens telephone number 67.62.34.

LAWRENCE RAICHT, Security Officer, American Embassy, Athens, Greece, advised that the above telephone number is assigned to CONSTANTINE KONTOS, 29 Kotta Street, New Psychico, Athens, Greece. As the Bureau is aware, KONTOS is a friend of subject whom ALEX was reportedly to visit in Greece.

To date no information has been received from the Italian National Police or Greek police sources who were alerted to subject's travel.

For the Bureau's information, LAWRENCE RAICHT advised on 2/8/63 that he had been requested by WILLIAM G. BEINERT, Internal Revenue Service (IRS) representative, American Embassy, Paris, France, to

JFK Law 11(a)

He indicated that when ALEX departed from Greece, he would comply with the request of Mr. BEINERT.
