GUD ALEX, AKA, AR. DAILY SUMMARY.

PCI [REDACTED] MANAGER, APARTMENT BUILDING AT ELEVEN FIFTY NORTH LAKE SHORE DRIVE, ADVISED THAT YESTERDAY MORNING TWO INTERNAL REVENUE SERVICE /IRS/ AGENTS WERE AT THE BUILDING ATTEMPTING TO LOCATE ALEX. HE SAID THEY WERE LACKING IN DISCRETION IN THEIR INVESTIGATION BY TALKING TO THE DOORMAN AND DESK CLERK AND OTHER PERSONNEL AT THE BUILDING ABOUT THE MATTER OF GUS ALEX/S BUSINESS AND ACTIVITIES AND CREATED A GENERAL DISTURBANCE AMONG THE PERSONNEL. HE SAID THEY WERE UNSUCCESSFUL IN TALKING TO ALEX WHO LEFT THE BUILDING HURRIEDLY WHILE THE IRS AGENTS WERE IN THE LOBBY OF THE BUILDING. PCI SAID THAT HE WAS NOT AT THE BUILDING AT THE TIME THE IRS AGENTS WERE THERE AND THAT THEY LEFT A MESSAGE FOR HIM TO CALL THEM, BUT THAT HE DID NOT WANT TO TALK TO THE IRS AGENTS DUE TO THEIR LACK OF DISCRETION IN CONDUCTING THEIR INVESTIGATION. INFORMATION RECEIVED FROM IRS DISCLOSED THAT IRS AGENTS

CG SIX THREE FOUR THREE DASH C ASTERISK ADVISED THAT HE HAD RECEIVED INFORMATION YESTERDAY FROM ALEX THAT A FEW DAYS AGO ALEX WAS AT THE SAINT HUBERT/S GRILL AND WHEN ALEX LEFT THE GRILL HE NOTED THREE POLICE OFFICERS OUTSIDE THE FRONT DOOR. INFORMANT STATED THAT ALEX WAS OF THE OPINION THAT THE OFFICERS HAD SURVEILLED AN ASSOCIATE TO THE GRILL. THE INFORMANT STATED THAT ALEX WAS SUCCESSFUL IN ELUDING THE SURVEILLANCE ON HIM. ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
