GUS ALEX, AKA. AR. DAILY SUMMARY. CG 6343-C ADVISED THAT IRVING "RED" WEINER IS A VERY CLOSE FRIEND OF ALEX, JOHN D'ARCO, LOUIS BRIATTA AND FRANK FERRARO. HE SAID WEINER HAS AN \$8,000 A YEAR JOB AS CHIEF OF SPECIAL SERVICES WITH THE CHICAGO PARK DISTRICT, BUT SPENDS LIKE A MILLIONAIRE AND HAS TRAVELED TO EUROPE ON TWO OCCASIONS AND MAKES FREQUENT TRIPS TO FLORIDA, ALL IN THE PAST THREE OF FOUR YEARS. HE SAID ABOUT EIGHT YEARS AGO WEINER WAS A GYM INSTRUCTOR FOR THE PARK DISTRICT AT A SALARY OF ABOUT \$3,000 A YEAR. HE STATED THAT HE IS CERTAIN WEINER IN THE PAST TWO OR THREE YEARS HAS RECEIVED LARGE SUMS OF MONEY FROM BEN STEIN OF THE NATIONAL MAINTENANCE CORPORATION. WEINER ALSO HAS CHARGE OF PIER MOORINGS FOR THE CHICAGO PARK DISTRICT.

STATED THAT IN HIS OPINION STEIN AND NATIONAL MAINTENANCE CORP. RECEIVED CONTRACT FOR MC CORMICK PLACE THROUGH WILLIAM MC FETERIDGE. MC FETERIDGE IS ON THE CHICAGO PARK BOARD, CHICAGO POLICE BOARD, AND ALSO IN CHARGE OF THE BUILDING EMPLOYEES UNION.
