WEEKLY AIRTEL SUMMARY

TP 50-C and TP 41-C advised 12/13/62 subject has not been reported in Tampa.

TP 50-C advised subject in no way has numbers "locked up" in Tampa. Source advised SAM TRAFFICANTE dislikes FRANK DIECIDUE.

HERB GOLDBURG, next-door neighbor to 2505 Bristol Avenue and Assistant State Attorney, advised SA JOHN R. BRETT December 13, 1962, subject has not been seen or heard of at 2505 Bristol, and he understands as a neighbor that subject remains most of the time in Miami, Florida.

Mr. WILLIAM KENNEY, Special Assistant to the Attorney General, while in Orlando, Florida, on 12/10/62, advised SA JAMES B. HAFLEY that FGJ impaneled at Orlando, Florida, and

[redacted] which adjourned on 12/10/62, and probably will not go back into session until shortly after 1/1/63.

Contacts with TP 79-C\* and TP 80-C\* on various dates in December, 1962, indicate JOE RAYMOND DIAZ not in contact with subject, and FRANK DIECIDUE apparently is not getting along with the TRAFFICANTE family.
