Informant said subject's wife paid the rent for November and gave no indication they were planning to move. Informant also said they gave no explanation as to where they had been for the past month.

MM 797-PC advised on 11/7/62 that he has observed the subject in George's Tobacco Shop, 23rd St. and Liberty Ave., Miami Beach, Fla., on several occasions but has not observed him there for several weeks.

It is noted George's Tobacco Shop is next door to Sonny's Restaurant, where the subject has been seen several times in the past.
