Information was received on 1/7/63 that JOSEPH INDELICATO (Miami File 92-404) is backed by the MANNARINO brothers of Pittsburgh, Pa., and an individual from New York known as "TONY/FATS". It is to be noted that ANTHONY SALERNO (Miami file 92-406) is known as "FAT TONY". Information was also received from this same source that INDELICATO is interested in establishing gambling in Jamaica and the Virgin Islands.

FLA. On 1/11/63, PASQUALE MICHAEL ~~WERRA~~ (Miami File 92-468) was observed at the residence of MICHAEL ~~COPPOLA~~ (Miami File 92-101). MM 509-C on 1/8/63 advised COPPOLA is presently hanging around at George's Newsstand, Miami Beach, and that the bookmakers who operated in this establishment for JUNIOR ~~LEVENS~~ON now book on the street. He said this change took place when COPPOLA began to make this his hangout as COPPOLA did not want the establishment raided for bookmaking while he was there. FLA.

FLA. This source also advised that WILLIE ~~WINTERS~~ and DAVE ~~GEIGER~~ have a bookmaking partnership going at the Sea Gull Hotel, Miami Beach, and that recently PHIL ~~KOV~~LICK of Hollywood, Fla., and a close friend of MEYER ~~LANSKY~~ (Miami File 92-102) acquired a piece of this operation. FLA.

FLA. MM 509-C advised that the Century Social Club, Miami Beach, closed up after the raid on the Patio Bridge Club, 12/13/62. The past week he learned BEN ~~HUSICK~~ (Miami File 162-80), his employees ALVIN ~~WEISBERG~~ and THEODORE ~~SKARON~~SKY and others, including HERKIE and HERMAN ~~WILENSKY~~, moved over to the Century Social Club from the South Beach Democratic Club as the latter club has also been closed since the above-mentioned raid. At the present time bookmaking and card playing is being carried on by the HUSICK group at the Century Social Club. FLA.

FLA. One of the individuals arrested in the raid at the Patio Bridge Club, Miami Beach, on 12/13/62 was FAYE ~~TUPLER~~. ROCKY ~~POMERANCE~~, Constable, Miami Beach, on 1/9/63 advised that FAYE TUPLER has a son-in-law that is an attorney and that she writes articles for the "Miami Beach Sun", a daily newspaper at Miami Beach.
