AT NEW YORK CITY, NEW YORK. Will contact sources in Central Park area, NYC, to develop information if subject MANOCCHIO and others are in this area.

AT SYOSSET, LONG ISLAND, NEW YORK. Will cover lead as set out in New York airtel to Memphis.

#### BOSTON

AT PROVIDENCE, RHODE ISLAND. Will conduct appropriate investigation to locate and apprehend subjects.

## ADMINISTRATIVE

Regular contacts were made with CIs and PCIs and C-TEs of the Boston Office concerning subjects MANOCCHIO and VENDITUOLI with negative results.

On 10/16/70, BS 942-C-TE advised SA WILLIAM J. WELBY he had been to NYC and saw BILLY CANDELMO who has his place of business at 9th and 44th Streets, NYC. During general conversations he mentioned to CANDELMO he had not seen or heard anything about subjects MANOCCHIO and VENDITUOLI. CANDELMO said he has not seen or heard from either subject.

On 11/3/70, BS 1159-C-TE advised SA DENNIS M. CONDON that LOUIS MANOCCHIO is in the Central Park, NYC, area, but informant had no specific address. Informant thought MANOCCHIO may be living in the Central Park area.

On 11/23/70 and 12/3/70, BS 1159-C-TE advised MANOCCHIO continues to hang around or live in the Central Park area of NYC.

On 12/23/70, and 1/5/71, BS 1159-C-TE advised MANOCCHIO is living in the NYC area and is sometimes up in the vicinity of Central Park. Informant has been unable to develop any information concerning subject VENDITUOLI.

Informant said he believes FRANK SALEMME and STEVE FLEMMI, Bureau Fugitives, are also in this area and MANOCCHIO has conversed with them.

Informant believes that LARRY BAIONE, La Cosa Nostra(LCN) member at Boston, who is friendly with MANOCCHIO, put MANOCCHIO in touch with SALEMME and FLEMMI.

On 1/13/71, the NYO advised as follows:

New York registration 1243-NA is listed to JOAN C. DELLICICCHI, husband ANDREW, 48 Preston Lane, Syosset, Long Island, N. Y., phones 516-921-5082 and 364-0577.

Nassau County, New York, Credit Bureau indicates listing for ANDREW DELLICICCHI at above address and shows employment with Great American Shows and Howard Amusements. It appears that ROCKY DELL" and ANDREW DELLICICCHI are the same person.

Frequent checks at 48 Preston Lane, Sysset, reflect that the DELLICICCHIS were not at their residence.

On 11/6/70, the Boston Office furnished the NYO with FD-302s for Sgt. THOMAS LEYDON, Sgt. DONALD KENNEDY, and Det. HAROLD CROOK of the Providence, R. I. PD, reflecting information that they could testify to the fact that MANOCCHIO and NICHOLAS BIANCO were close friends in Rhode Island.

On 12/4/70, the NYO advised the Bureau that on 12/4/70, the general activities of NICHOLAS BIANCO were discussed with Special Attorney JAMES O. DRUKER, Organized Crime Unit, Eastern District of New York, Brooklyn, N. Y. BIANCO, when interviewed by BuAgents, NYO, on 10/8/70, denied knowing MANOCCHIO.

Since New York received the interviews of the three Providence, R. I., Police Officers, DRUKER issued a subpoena for to appear before a Federal Grand Jury, Eastern District of New York, on 12/16/70.
