THE FOLLOWING INDIVIDUALS ARE BEING CONSIDERED AS  
CO-CONSPIRATORS IN THE CONSPIRACY COUNT:

MARCO RODRIGUEZ, JORGE GUTIERREZ, ANDRES GONZALEZ GONZALEZ,  
JESUS DOMINGUEZ BENITEZ, AIMEE MIRANDA, AND PAULINO GUTIERREZ.

ALL OF THESE INDIVIDUALS EXCEPT MIRANDA AND PAULINO  
GUTIERREZ HAVE BEEN IDENTIFIED WITH BACKGROUND MATERIAL TO  
THE BUREAU AS SUSPECTS IN THIS MATTER. MIRANDA IS THE  
GIRL FRIEND OF BOSCH IN WHOSE APARTMENT THE RECOILESS RIFLE  
USED ON THE "POLANICA" WAS ASSEMBLED AND PAULINO GUTIERREZ  
IS THE FATHER OF JORGE GUTIERREZ AND WAS PRESENT WITH BOSCH  
AND MORALES IN THE VICINITY OF THE SHELLING OF THE "POLANICA".

MEADOWS INDICATED HE NOW PLANNED TO USE AS WITNESSES  
BEFORE THE GRAND JURY BUAGENTS [REDACTED] AND [REDACTED]

IT IS STILL ANTICIPATED THAT GRAND JURY TESTIMONY WILL BE COMPLETED BY THURSDAY NEXT AND THAT THE WARRANTS OF ARREST WILL BE AVAILABLE FOR EXECUTION ON FRIDAY. CONSIDERATION IS STILL BEING GIVEN TO HAVING SEARCH WARRANTS ISSUED RE BOSCH'S HOUSE AND CAR AS WELL AS MIRANDA'S APARTMENT SO THEY MAY BE EXECUTED SIMULTANEOUSLY WITH THE ARRESTS. NO DECISION WAS REACHED WITH REGARD TO THE SEALING OF THE INDICTMENTS AND THIS OFFICE AGAIN RECOMMENDED TO MEADOWS THAT STRONG CONSIDERATION BE GIVEN TO HAVING THEM SEALED.

THE BUREAU WILL BE IMMEDIATELY ADVISED WHEN THE DECISION RE THE FINAL FORM OF THE INDICTMENT IS REACHED.
