of woman recalled, and person driving motor home and its description not noted. Subject not registered Ramada Inn. Cutlass recovered by Tucson representative Peoples National Bank, Tyler, Texas, on April 4, 1973, in presence of FBI. Vehicle examined, but only papers found were car papers in name of OLETA SHAW, 3403 Cope, Tyler, Texas. No indication current whereabouts. Interior of car and trunk obviously cleaned out prior to abandonment.

As no indication motor home or subjects currently in Tucson area, matter not being presented to U.S. Attorney, Tucson, Arizona. Phoenix files reflect GROSSI born August 20, 1927 at Patterson, New Jersey, rather than August 20, 1947.

CS LA 4143-S advised on April 3, 1973, that telephone number (213) 949-3107 is listed to MANUEL M. MIRELES, 9711 East Nan Street, Pico Rivera, California. Source further advised telephone number (213) 469-0600 is listed to ROSE MARY PONCE, 5745 Camerford, Hollywood, California, and telephone number (213) 628-0333 is listed to Robinson's Department Store, 600 West Seventh Street, Los Angeles, California.

On April 5, 1973, MANUEL MIRELES, (Supra) advised the subject and JACK BOWEN are not known to him. He stated that his brother-in-law, PAUL PEREZ, is currently living with him and might possibly be acquainted with the subject.

Attempts to contact PAUL PEREZ on April 5, 1973, April 6, 1973, and April 9, 1973, met with negative results. On April 10, 1973, PAUL PEREZ born November 14, 1928, at Los Angeles, California, advised he was released in April, 1972, from La Tuna, Texas Federal Penitentiary. While incarcerated there, he became friends with a fellow inmate by the name of JACK BOWEN. BOWEN was also released in April, 1972, and on a couple of occasions shortly thereafter, telephoned PEREZ from Tyler, Texas.
