Synopsis: Subject returned to NYC from Cuba 8/25/66. Resides with wife, LENNA SCHWEITZER JONES and three children at 340 Haven Avenue, Apartment 5-S, NYC. Subject is unemployed. Subject refused interview 8/26/66 and 9/1/66 with Special Agents of the Federal Bureau of Investigation.

DETAILS:

Immigration and Naturalization Service (INS) Headquarters, Washington, D. C., advised the Federal Bureau of Investigation on August 26, 1966, that LOUIS HENRY JONES was in possession of United States Passport 1595958 and arrived in Montreal, Canada, on August 25, 1966. Subsequent to his arrival in Canada, JONES received money from his wife in the United States.

In connection with an investigation of the subject's wife, LENNA SCHWEITZER JONES, the following information was developed:
