activity is operating a small "book" out of his residence in Arabi, New Orleans, La. He estimated his daily income as being between \$15 to \$20 and, although wagers are accepted from persons locally on out-of-state and Louisiana race tracks, he does not pay off on any bets until the next day, when race results are published in New Orleans papers. He claims he receives no wire service for any wagering information from out of state and has not done so since the NOLA Printing Company ceased providing his wire service in late 1961 or early 1962.

During interview of AIOLA, he accepted two horse bets on races to be run at Jefferson Downs, New Orleans, that evening. He exhibited daily tally sheets and interviewing Agent noted not over ten entries on any one day's sheet. AIOLA said he had a Federal Wagering Stamp.

Previous investigation and inquiry after interview of AIOLA by IRS, New Orleans, revealed AIOLA did not have a Federal Wagering Stamp; however, IRS officials stated AIOLA's paper work concerning his stamp may not yet have cleared. Information regarding AIOLA's wagering activity was provided to IRS.
