UNKNOWN SUBJECT USING TELEPHONE  
AT 1530 VETERANS HIGHWAY

Information has been received from the SBT&T Co. reflecting that an unknown individual has been using the public pay telephone located at 1530 Veterans Highway, New Orleans telephone number 835-9151, to call Las Vegas, Nevada, Youngstown, Ohio, Washington, D. C., Miami, Florida, and Chicago, Illinois. The calls to Washington, D. C., were to ROBERT L. MARTIN, 2109 Spruce Drive, who is believed to be an active gambler in the Washington, D. C. area. The calls to Chicago, Illinois, were to a CHARLES K. MC NEIL, who is believed by the telephone company to have at one time accepted football bets. The calls to Miami, Florida, were to a MICHELLE KANE. These calls are a continuation of a series of calls which were discovered by the telephone company which were being made in August, 1962, from another pay telephone, number 482-9448. A case is being opened to check out the individuals receiving these calls. A new case is being opened entitled "UNSUB.; New Orleans Telephone Number 835-9151."
