NO 1207C advised 2/13/63 that the race horse service to handbooks in Jefferson Parish from the New Orleans Fairgrounds at this time is very poor. The informant advised that ABEL JOHN CHAUVIN, who is providing the service, is apparently obtaining the results from another service and simulating an actual call of the race. Informant advised that CHAUVIN called a race recently where the newspaper account reported that the horse ran in front from start to finish whereas CHAUVIN's call had the horse starting late and moving up from fifth position to win the race at the finish line. Informant advised that the DOMING brothers and LAMBERT MICHELLI are putting out Fairgrounds race results to the handbooks located on the Westbank of the Mississippi River in Jefferson Parish.
