On May 28, 1962 PCI _______advised that CARLOS MARCELLO issued gate passes to people entering Churchill Farms, Inc. The card reads as follows:

"PERMANENT GATE PASS

"Churchill Farms, Inc.

"Admit (number of people)

"through the gate of Churchill Farms for fishing privileges. This pass strictly personal and any loss must be reported to the person whose signature appears below."

The card is signed CARLOS MARCELLO.

PCI said that anybody attempting to enter Churchill Farms will be stopped and asked for his pass.

By letter dated June 21, 1962 the New York City Office advised that New York informant 3368—C had been interviewed on May 18, 1962 by SAs WARREN J. DONOVAN and JAMES P. FLYNN and again on June 12, 1962. This source furnished the names of a group of individuals who were either talked about or pointed out to him as being members of the Italian Criminal Syndicate in the areas in which they reside. Among this group was CARLOS MARCELLO of New Orleans.

The Philadelphia Office by communication dated July 18, 1962 in the case of ANGELO BRUNO-AR, advised that
