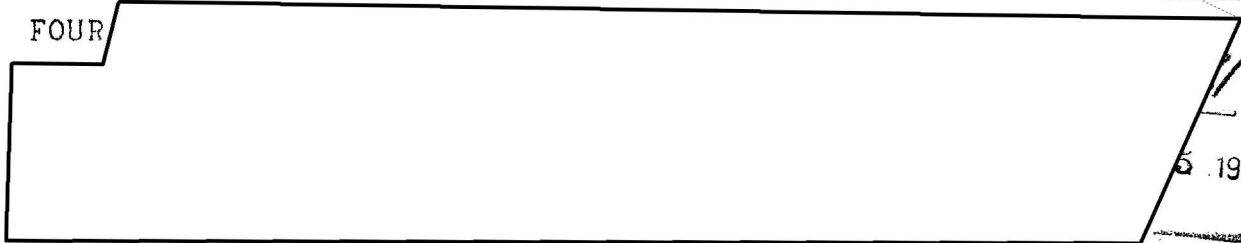
SAM JOHNSON, U. S. CUSTOMS AGENCY, TAMPA, ADVISED SEPT.

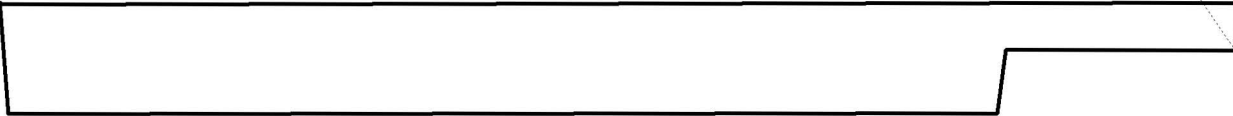
