USA EDWARD F. BOARDMAN ADVISED FIVE P.M. NOVEMBER TWENTYTWO LAST HE HAD TELEPHONICALLY CONTACTED DEPARTMENT ATTORNEY WILLIAM KENNEY, WHO WAS IN WASHINGTON, D.C. AT SUCH TIME AND REQUESTED HIS ADVICE CONCERNING ISSUANCE OF SUBPOENA BEFORE FGJ, MIAMI, DECEMBER THREE NEXT. STATED KENNEY TO DISCUSS MATTER WITH MR. WILLIAM HUNDLEY, AND HE NOTED THAT [REDACTED], AND WILL NOT SAY ANYTHING ABOUT THEM, TAKING THE FIFTH AMENDMENT BEFORE FGJ, AS HE DID IN ORLANDO, FLA., IN PAST. BOARDMAN, AS SOON AS HE HEARS RESULTS OF ABOVE REFERRED TO CONFERENCE, WILL IMMEDIATELY ADVISE.

SOURCES HAVE NOT REPORTED SUBJECT IN TAMPA. TP ELEVEN AND TP FIFTY CONTACTED NOVEMBER TWENTYFIVE, ADVISED SUBJECT HAS NOT BEEN SEEN NOR REPORTED IN TAMPA.
