On 10/2/63 Bureau Agents observed LITTLE's runner MARVIN COX driving in the downtown area of Dallas with a young blonde female. It was noted he had changed the license plates on his car and now had dealer's plate P2 7401.

RE: GIIF - Wichita Falls, Texas
(DL 94-50)

District Attorney STANLEY KIRK, Wichita Falls, Texas, has advised Sheriff VANCE is scheduled to be the subject of an inquiry by the Grand Jury. He explained VANCE had taken a trip to Key West, Florida, several months ago to pick up a prisoner and had taken a woman, GREDTRUDE MARIE CAVET with him. KIRK stated VANCE and CAVET registered as man and wife while in Florida and then brought the prisoner back with them to Wichita Falls, Texas.

KIRK further advised this woman was arrested for assault with intent to murder on 4/12/62, after shooting her husband to death at Wichita Falls. She was lodged in

the Wichita County Jail awaiting trial and on 12/6/62, received a five year probated sentence for murder without malice. According to KIRK, Sheriff VANCE was having an affair with CAVET while she was his prisoner. He advised she is willing to go before the Grand Jury and testify as to her relationship with the Sheriff.

CAVET is described as a white female, in her 30's, and she has FBI #147326E.

RE: HARRY REIMER URBAN

On 10/1/63, Bureau Agents observed URBAN on the north side of Dallas driving his 1959 white and lavender Oldsmobile and accompanied by a young blonde and a small child. The car had Texas license PE 1388 which is registered to a JOHN PRICE for a 1962 Chrysler. URBAN was observed by the Agents going to a shopping center and then to a residence recently built in Northeast Dallas at 10512 Robindale Drive. URBAN was known to reside in an apartment house on the northwest side of Dallas. The blonde has not been identified to date.

RE: LAWRENCE IRVIN PERKINS

Recently Dallas received a request from San Diego Office to conduct investigation of the subject who had been reported by the TRP, Del Mar, California, as a professional gambler and possibly a bookmaker, fronting as a horse owner. Prior to the receipt of this, Dallas had received information from DL 185-C-TE that PERKINS was a known crooked gambler operating out of Las Vegas and associated with Dallas crooked gambler WILLIAM RAY DAVIS (DL 166-110). This informant had also previously identified another crooked gambler and associate of DAVIS and PERKINS as a man named MELVIN. San Diego advised that PERKINS had been in contact with Dallas telephone FL 1-1759. This phone is listed to ALLEN MINTER, Apartment 214, 3919 Inwood Road. No record of MINTER could be located through credit and criminal checks, Dallas.
