Legat, Madrid advised by communication dated October 26, 1961 that continued contact with available Cuban sources failed to result in finding anyone able to get to FREDESVINDO BOSQUE CUETO to question him concerning the subject. Legat advised RUBEN BATISTA, son of ex-President FULGENCIO BATISTA, has continued to be out of Madrid and it has not been possible to make inquiry through him of ARSENIO LABRADA LEON regarding subject.

D. GENERAL ACTIVITIES AT TAMPA, FLORIDA

TP T 2 advised SAs O'BRIEN and LABADIE on October 27, 1961 that SANTO TRAFFICANTE was definitely not in Tampa and that there was no indication that subject was to return to Tampa from Miami. Source understood from his close associate, AUGUST C. PANIELLO, subject's son-in-law, that subject will continue to reside in Miami.

SAS O'BRIEN and LABADIE observed the activities of AUGUST C. PANIELLO and JAMES C. LONGO on November 2, 1961 at the Columbia Restaurant, however, no information concerning subject's location was determined.

TP T 4 advised on night of Nowember 6, 1961 that his close associates JAMES LONGO, JIMMY BRUNO, NICK SCAGLIONE and SAM TRAFFICANTE all believe subject is still in Miami. Source said it was impossible to directly ascertain an address for subject in Miami.

CASIMIRO HERNANDEZ, JR. advised SA LIONEL E. BELANGER on November 7, 1961 that subject was residing in Miami but that he did not know where subject was residing there. He added that subject did not devulge his address or business.

TP T 2 advised SAs O'BRIEN and LABADIE on November 8, 1961 that JACK PARRINO, AUGUST C. PANIELLO and JOHN RIVERA, aka., "Scarface", had been observed together at RIVERA's 22nd St. Bar, that it was overheard RIVERA had to see SANTO TRAFFICANTE, and that PANIELLO related the information that the possibility existed that SANTO TRAFFICANTE may make a visit to Tampa. Source advised he would maintain close limison with these persons to learn of the exact possible plans of subject and should any information develop, the FBI would be immediately advised.
