On 2/6/61, PG 622-C* was effectively contacted at the North Star Cement Block Co., Pittsburgh, Pa., owned and operated by SEBASTIAN JOHN LA ROCCA, Pittsburgh National Top Hoodlum.

On 2/4/61, PG 615-C advised that on that date ANDREW MANGINI was married to BEVERLY SERVENTI in New Kensington, Pa. GABRIEL MANNARINO, Pittsburgh National Top Hoodlum and MANGINI's employer, was best man, and SAMUEL MANNARINO, Pittsburgh National Top Hoodlum, was in attendance. GABRIEL MANNARINO allegedly paid the bills for the wedding and reception totaling about \$7000. MANGINI assists the MANNARINOS in the operation of their gambling establishments in the New Kensington area. Several of the guests were said to be from out-of-town. Contact has been made with the professional photographer who took both still and motion pictures at the wedding and reception. MANGINI is reputedly honeymooning in Hawaii.

Information has been received from Intelligence Division, IRS, Pittsburgh.

New Kensington. Shortly thereafter, PG 615-C advised he had purchased a lottery ticket from a New Kensington numbers writer, who told informant that the same ticket could be purchased in Youngstown, Ohio. A new case was opened and is being vigorously investigated.
