Phila. PD today on standby with a search warrant in event BRUNO entered 740 Christian St. BRUNO, however, met with his Lieutenant PHILIP TESTA and did not enter instant address. This activity will be pursued further.

PH 269-C has previously informed that BRUNO collected \$180,000.00 for damages done to his gambling casino, Havana, Cuba, January 1959.

By letter 4/27/61 Legal Attache, London, furnished following information:

JFK Act 6 (4)

Col. [REDACTED] British Secret Service MI-5 (protect identity, do not disseminate outside Bureau) through sources ascertained that Lloyds of London had acted as re-insurer for the American International Re-Insurance Corp., New York City, to the extent of \$70,000.00 for a policy made out to subject in connection with gambling casino at Plaza Hotel, Havana, Cuba. In April 1959 a claim for \$185,000.00 presumably by the American International Re-Insurance Corp. was paid to subject in respect to a fire at instant gambling casino Jan. 1, 1959. (X)

[REDACTED] it appears that verification of this information would be basis for prosecution by IRS.

New York requested to immediately ascertain the above information and furnish leads to interested auxiliary offices, at which time New York should furnish the following information: [Col. [redacted] in making above information available respectfully requests that no dissemination of this information be made outside the Bureau; that extreme discretion be used in connection with this information in order that the American International Re-Insurance Corp. would not know that the original information came from the Lloyds organization in London.] (X)

All inquiries should ascertain the identity of BRUNO and any other individuals interested in the ownership or insuring of the above gambling casino.

All investigation this matter should be reported on FD 302 in which persons to properly subpoena for records will be identified. Any samples of BRUNO's handwriting should be obtained from records and forwarded to the FBI Laboratory for identification.
