Crapisi has furnished information concerning the structure of the Italian organization in Kansas City but has not in the past placed it in the framework of the broader organization; Cosa Nostra, and has not employed terminology similar to that used by Joseph Valachi. It is requested that Crapisi be interviewed again, specifically with regard to the type of information furnished by Joseph Valachi.
