LA 4268-C has not observed ROSSELLI at the Friars Club in Beverly Hills, California, during the past week and periodic check of the garage at ROSSELLI's apartment revealed that his car has not been observed in the garage during the past week.

In Los Angeles airtel dated 12/2/63 it was set forth that ROSSELLI picked up JUDITH CAMPBELL at the Beverly Crest Hotel on 11/27/63 when she checked out of the hotel stating she was going to Las Vegas for the weekend. On 12/18/63, LA 4393-C advised that over the Thanksgiving weekend he saw ROSSELLI and JUDITH CAMPBELL at the Metropole Restaurant in Palm Springs, California. On this occasion JACK BARENFELD and his wife were with ROSSELLI and JUDY CAMPBELL. BARENFELD is a friend of MAURICE H. FRIEDMAN and ROSSELLI, and is associated with FRIEDMAN in some real estate investments in the Los Angeles area.

It has been previously reported that in the latter part of October 1963 a 1963 Cadillac, California license JRV 639, was parked in ROSSELLI's apartment garage stall. It has been ascertained that this car is leased from the Allen Auto Leasing Company, Los Angeles, by

JOHN CARGERMAN, who is President of the Los Angeles office of Cooperative Motel Directories, a Chicago firm.

BEN FARBER, AUSA, Los Angeles, advised that the Special Investigative Division of the U. S. Attorney's Office is seriously contemplating holding a grand jury in Los Angeles to question [redacted]

[redacted] PCI, advised on 12/18/63 that JUDITH CAMPBELL returned to the Beverly Crest Hotel on 12/3/63 and remained until 12/17/63. During her stay at the hotel in this period, one of the hotel employees observed MAURICE H. FRIEDMAN hand JUDY CAMPBELL an envelope with an unknown amount of money in it. She paid her hotel bill, which amounted to over \$600.00, in cash.

Inasmuch as ROSSELLI's whereabouts have not been known since about 12/17/63, the day JUDY CAMPBELL checked out of the Beverly Crest Hotel, it is possible ROSSELLI and CAMPBELL may again have gone to Palm Springs, California.
