Re Newark letter to Bureau dated 1/24/64 and New York letter to Bureau dated 2/5/64.

On 2/5/64 NK 2251-C* advised that the Union City crap game had been moved to Newark, N.J.

During February, 1964, NK 2251-C* advised that [redacted] had caused all of his operations to be closed down because of his subpoena to appear before the Federal Grand Jury in [redacted] on [redacted] and because of his fear of possible arrest by the New Jersey State Police.

On 3/17/64 NK 2228-C advised that the Union City crap game had moved to Newark, N.J., and was presently closed.

This case is being closed by the Newark Office until such time as additional information is received indicating that it has been reactivated.
