AT CHICAGO, ILLINOIS: (1) Will reinterview ROBERT W. NOTTI, Assistant to EDWARD J. BARRET, Clerk of Cook County, Illinois, regarding his association with JOHN ROSSELLI and determine:

(1) What is the information he states he is aware of concerning ROSSELLI's background and reputation, specifically what he knows of ROSSELLI's associates and activities in Chicago, ROSSELLI's position, status or reputation in Las Vegas, Nevada, and his associates, sources of income and any other information concerning his activities in Las Vegas.

(2) What advice did ROSSELLI give to NOTTI re the collection of the million-dollar gambling debt allegedly owed by JOHNNY DREW to H. L. HUNT.

(3) Who suggested to NOTTI that ROSSELLI might be of help in such a situation and what was the basis given for recommending ROSSELLI.

(2) Will furnish any information available concerning ROSSELLI's relationship with EDWARD J. and JEANNE BARRETT.
