BALLETTI has advised that while in Las Vegas in October 1960, he received instructions from MAHEU to contact T.W. RICHARDSON at the New Frontier Hotel and RICHARDSON would pay him \$1000 for the work being done by BALLETTI and the UNSUB in Las Vegas. U

T. W. RICHARDSON has denied knowing BALLETTI or paying any money to BALLETTI or anyone else in connection with this matter. It is noted that ROSSELLI has in the past contacted T. W. RICHARDSON. ROSSELLI also in the past has contacted ROBERT MAHEU. U

Leads are also outstanding in the BALLETTI investigation to reinterview MAHEU to determine if JOHN A. ROLLINS is identical with JOHN ROSSELLI. Also, leads have been set out to have ROSSELLI's handwriting compared by the FBI Lab with the signature of J. A. ROLLINS at the Kenilworth Hotel and the signature of J. W. HARRISON at the Riviera Hotel. U

The results of this investigation will be set out in future ROSSELLI reports and in the event it is determined that ROSSELLI actually is involved in this matter, the information will be incorporated in the ROSSELLI reports. U
