LA 4396-C* has furnished information that ROSSELLI continues to reside at his Los Angeles apartment but has been unable to furnish other information concerning ROSSELLI's activities.

LA 4268-C advised ROSSELLI was at the Friar's Club in Beverly Hills during the afternoon of 4/12/63. This source also reported that ROSSELLI arrived at the Friar's Club at about 5:00 p.m. on 4/15/63. Source was of the opinion that ROSSELLI arrived at the club with SIDNEY KORSHAK, well known Chicago and Los Angeles attorney.

Analysis of information furnished by LA 4396-C* on 3/29/63 indicates that a woman addressed by ROSSELLI as DOROTHY was DOROTHY BEAL who operates a dress shop in Beverly Hills, California and who formerly had a dress shop at the Sands Hotel in Las Vegas, Nevada. It was further indicated BEAL and ROSSELLI were discussing MARGARET KASTEL widow of PHIL KASTEL, builder of the Tropicana Hotel.

BEAL indicated that she had recently seen Mrs. KASTEL and would probably see her again. ROSSELLI told BEAL to tell her (Mrs. KASTEL) to send a copy of

copy "of that" to J. P. CANTILLON (JAMES P. CANTILLON, attorney and close friend of ROSSELLI in Los Angeles). ROSSELLI said she (Mrs. KASTEL) does not have to talk to them and can tell them to go jump in the lake. ROSSELLI told DOROTHY that he was going to Las Vegas and would be at the Desert Inn Hotel and she should call him if she comes to Las Vegas.

LV 10-C advised that on 4/7/63 a Miss DOROTHY BEALE attempted to contact ROSSELLI at the Desert Inn Hotel in Las Vegas. She left a message for him to contact her at Room 244 at the Sands Hotel.
