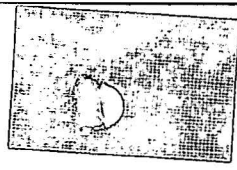

YOU WERE PREVIOUSLY ADVISED OF THE FACT THAT ERNEST INFELICE, AMERICO
DIPIETTO AND FRANK GALLO, OF SO CALLED QUOTE NORTH AVENUE STEAK
HOUSE GANG END QUOTE, WERE IN NEW YORK CITY JUNE THREE LAST, PURPOSE
UNKNOWN. NEW YORK OFFICE ADVISED THAT INVESTIGATION REVEALS INFELICE,
GALLO AND DIPIETTO WERE REGISTERED IN ROOM FOURTEEN SIXTY ONE AND TWO,
PARK SHERATON HOTEL, NEW YORK CITY, JUNE TWO LAST, AND ANTICIPATED
DEPARTURE, NEW YORK CITY, JUNE FOUR LAST. HOTEL RECORDS INDICATE
MODE OF TRAVEL OF THESE INDIVIDUALS AS BY AUTOMOBILE. FURTHER INVEST-
IGATION BEING UNDERTAKEN BY NEW YORK CITY TO ASCERTAIN REASONS FOR
THEIR PRESENCE THAT AREA. NOTED THAT CG SIX FOUR FIVE SEVEN DASH PC

FURTHER CONTACT WITH GIANCANA OR DOMINICK BLASI. JUDITH CAMPBELL, LOS ANGELES, WAS INTERVIEWED AT LOS ANGELES AND ADVISED THAT SHE MET GIANCANA ABOUT FIFTEEN MONTHS AGO AT THE FONTAINEBLEU HOTEL, MIAMI BEACH, FLA., UNDER THE NAME OF SAM FLOOD. SHE HAS SEEN HIM THREE OR FOUR TIMES SINCE. SHE QUOTE RAN INTO GIANCANA END QUOTE ON THE STREET IN NEW YORK CITY A SHORT TIME AGO, BUT WOULD NOT ELABORATE ON THIS. SHE DECLINED TO FURNISH ANY FURTHER INFO CONCERNING THE IDENTITIES OF THE INDIVIDUALS WHO INTRODUCED HER TO GIANCANA. MISS CAMPBELL WAS FORMERLY WITH JERRY LEWIS PRODUCTIONS, HOLLYWOOD, AND IS NOW A FREE LANCE ARTIST. DEPARTMENTAL ATTORNEY ROBERT J. ROSTHAL ADVISED THIS DATE THAT SUBPOENA FOR [REDACTED]
