On 7/31/61, the above name was furnished to Agent SCHWARTZ, and on 8/1/61, SCHWARTZ advised that NOLL affirmed that CHRIS SUPRANO was the girl to whom he had referred. JFK Law 10(a)2

On 8/1/61, testified as had been expected, and on the same date, DJ Attorney KEHOE said testimony, coupled with testimony of about 29 other witnesses before the November, 1961, FGJ, would probably result in IRS indictments against SAM and KELLY MANNARINO plus WILLIE SAMS, as proprietors of Nuken Novelty Company and against JENNIE MORENO, RAY CALGAGNO and TONY WARDOCLIP, as employees.

New Kensington, Pa., Mayor RAYMOND GARDLOCK and the majority of his City Councilmen have been "owned" by the MANNARINOS since their election approximately eight years ago. At one time, at the instructions of KELLY MANNARINO, "wired" the New Kensington City Council chambers so that tape recordings of the proceedings could be made.

Chief JOHN BORDONAROO, New Kensington, Pa., Police Department, is the personal selection for the job of KELLY MANNARINO.

It is noted that Mayor RAYMOND GARDLOCK of New Kensington was defeated in the primary elections of May, 1961, and will not be a candidate for re-election in the general elections of November, 1961.

The August 29, 1961, edition of the "Daily Dispatch," daily newspaper published in New Kensington, Pa., carried an editorial entitled "The MANNARINOS Rule." This editorial is as follows:

"That the Mannarino mob owns the administration of Mayor Raymond E. Gardlock lock, stock and barrel and has absolute control of Chief John Bordonaro's police department was conclusively demonstrated to the satisfaction of even the most skeptical last Thursday during the raid on the notorious gambling casino.

"For three hours not a policeman showed up to regulate traffic in the vicinity or to control a crowd upwards of 500 which formed while the federal agents were at work.

"To offer the excuse, as city hall has done, that the police department did not know what was happening is ridiculous and no one in his right mind will believe it. You can be sure that police officials knew all along exactly what was happening and that the failure to send officers to the scene was deliberate. And they also knew right along of the existence of the casino and yet never raised a finger against it. To ask why they failed to act is needless - everyone knows.

PG T-3 is a physician whose professional services have on occasions been used by members of the MANNARINO organization and who frequents MANNARINO controlled gambling and after-hours establishments.

PG T-4 is a Pittsburgh, Pa., man who has acted as a consultant to the MANNARINOs in connection with some of their legitimate enterprises.

PG T-21 is a Pittsburgh, Pa., businesswoman who frequents places where gamblers and racketeers congregate.

PG T-24 is operator of an Allegheny County, Pa., gambling casino which competes with the MANNARINO casino.

PG T-25 is a man with current activities regarding numbers, horse bets, and sports bets in New Kensington, Pa., and surrounding area.

PG T-28 is a man with experience in used cars, prostitution, robbery and burglary who is readily accepted by racketeers throughout the country.

PG T-29 is a man who has been associated with narcotics, prostitution and vice of all kinds for over 15 years in the Pittsburgh, Pa., region.
