Enclosed for Los Angeles are nine copies each of FD-302's, one reflecting interview of KATHLEEN HORDEN, aka, and one reflecting observation of ROSELLI and HORDEN arriving at the Las Vegas airport. Also enclosed for Los Angeles is one photograph of KATHLEEN ROTHMAN, aka Kathleen Horden.

LV 129-PC advised SA WAYNE H. DRAKE on 3/30/64, that the informant had not observed ROSELLI around the Desert Inn Hotel for quite some time. Informant said that ROSELLI's former girl friend, VICKIE LOCKWOOD, is no longer employed as a showgirl at the Desert Inn Hotel, but is presently employed as a chorus girl at the Sands Hotel. *B*

LV 10-C advised SA R. BURNS TOOLSON on 4/10/64, that ROSELLI checked into the Desert Inn Hotel late on 4/9/64. He was assigned to room 2604, and listed a home address of 1333 South Beverly Glen Boulevard, Los Angeles, California.

LV 80-C advised SA M. B. PARKER on 4/13/64, that he had observed ROSELLI in the lounge of the Desert Inn Hotel on the night of 4/10/64, in conversation with NICHOLAS DANALFO, aka "Peanuts."

LV 10-C advised SA R. BURNS TOOLSON on 4/13/64, that ROSELLI checked out of the Desert Inn Hotel on 4/12/64. On 4/11/64, a Miss DONNA DALE, telephone number 735-1895, attempted to contact ROSELLI.

On 4/28/64, SAs WILLIAM T. MC FAUL and ARTHUR N. BARRETT observed ROSELLI arriving at McCarran Field, Las Vegas, Nevada, accompanied by a white female with red hair, who was unknown to SAs MC FAUL and BARRETT. Information relative to their observation is set forth in FD-302 enclosed for Los Angeles. It is noted the vehicle which picked up the female and ROSELLI bearing Nevada license C39115 is registered to J. or K. HORDEN, 2908 Burton Street, Las Vegas, Nevada.

Shortly after HORDEN's arrival at her residence, attempt was made to interview her by SAs LEWIS A. FAIN and WARREN E. SALISBURY, it being noted that a PCI case had been opened on HORDEN on 1/10/64, in an effort to develop her into an informant. HORDEN advised she had returned from Los Angeles early on the afternoon of 4/28/64, and that JOHN ROSELLI was on the same plane; however, she denied they were traveling together and stated she had not been with ROSELLI in Los Angeles. She stated she had known ROSELLI for about two years.

LV 10-C advised SA R. BURNS TOOLSON on 4/28/64, that ROSELLI was scheduled to arrive in Las Vegas on 4/28/64, and would remain for six nights. His reservation was made on 4/25/64, by MAC RIDD, Hotel Manager, and he was scheduled to occupy room 2801.

LV 10-C advised SA M. B. PARKER on 4/30/64, that ROSELLI, on 4/29/64, called from room 2801, Desert Inn Hotel, to Chicago, Illinois, number 943-1155.

LV 80-C advised SA M. B. PARKER on 4/30/64, that the informant had received information that subject had recently been going out with KATHY HORDEN, a former cocktail waitress at the Desert Inn Hotel. Subject allegedly became quite friendly with HORDEN when HORDEN and MAXINE CULLINS, another cocktail waitress from the Desert Inn Hotel, were in New York City several weeks ago.

HORDEN has been employed for quite some time as a cocktail waitress in the pit at the Desert Inn Hotel. Until recently, she had been very friendly and had appeared to be going steady with LINDSEY CROSBY, youngest son of BING CROSBY, nationally known entertainer. She has been contacted on several occasions in connection with development as a PCI and until the contact on 4/28/64, had presented a friendly attitude and had furnished some information relative to her association and contacts in the Las Vegas area. On the contact on 4/28/64, she appeared somewhat belligerent and upset and declined to furnish any information of value.

In view of the information set forth in Los Angeles airtel to the Director on 4/24/64, which reflects that on 4/23/64 [redacted] PCI, currently appearing as an entertainer at Dino's, a night club on Sunset Strip, advised that on 4/17/64, ROSELLI came there for dinner with a red headed girl friend. ROSELLI introduced the girl to [redacted] as KATHY and gave her no last name. [redacted] stated she did not know the girl and does not know her last name.
