CG T-6 has advised as follows:

JFK Law 11

CG T-7 advised on September 28, 1961, that BARNEY BAKER, who was recently staying in room 718 of the North Park Hotel, 1931 North Lincoln Parkway, Chicago, is a close associate of GUS ZAPAS and JAMES HOFFA.

SANDY SMITH, Police Reporter, "Chicago Tribune," has advised that BARNEY BAKER is a known slugger for the Teamsters Union who is presently appealing a recent conviction for violation of the Anti-Racketeering Statute in Pennsylvania.

CG T-8 advised on September 18, 1961, that JOE NICOLETTI, who resides in the vicinity of 5700 West Madison Street, Chicago, has plans to take over the Machinery Movers Union after ERNIE GIBAS goes to prison on a conviction in Federal Court in connection with "labor racketeering."

CHARLES LA TOUR, according to this source, also has plans to "take over" this union, but NICOLETTI has stronger backing from the "outfit." NICOLETTI testified for TONY ACCARDO in the latter's income tax trial and as a result, NICOLETTI was indicted for perjury. If NICOLETTI goes to jail in connection with that indictment, LA TOUR will then be able to "take over" the union, according to the source, or if NICOLETTI is not convicted, both LA TOUR and NICOLETTI will run the union.

On October 31, 1961, Assistant United States Attorney JOHN P. LULINSKI advised SA C. LEONARD TREVIRANUS that appeal briefs on behalf of ERNEST GIBAS, MICHAEL BYRNE, and DONALD FULTON, in connection with their conviction, November 22, 1960, for violation of the Taft-Hartley Act, were filed on October 23, 1961. The Federal Government has thirty days in which to reply thereto.

On November 21, 1961, Assistant United States Attorney RAYMOND K. BERG advised SA TREVIRANUS that the perjury trial of JOSEPH NICOLETTI was scheduled for December 4, 1961, and insofar as he knew, the trial would proceed as scheduled.
