INFORMANTS

NY 3612-C-TE has been in daily contact with the NYO regarding this case. Through the efforts of NY 3612-C-TE, FRANCIS KAHN was replaced as JOHN BELAVENITZ's attorney and JAMES MC DONALD presently represents BELAVENITZ. BELAVENITZ was formerly MARILYN JEAN FRASER's pimp and could testify to admissions by FRASER and SCHWARTZBERG and also to his dealings with SCHWARTZBERG. [redacted] is presently in New York City on a writ and will go before the Federal Grand Jury within the next week. To date [redacted] has not indicated a willingness to cooperate, but AUSA FANNING believes he may testify shortly.

Telephone toll check on MARILYN JEAN FRASER, set forth in this report, reflects a toll call from HELEN JASPAR. NY 3612-C-TE advised 3/9/65, that HELEN JASPAR also known as Helen Raines, presently resides at the Hotel Albert, 23 East 10th Street, Room 60⁹, New York City, and has stated to individuals that she prostituted herself for KONIGSBERG after KONIGSBERG tired of FRASER. NY 3612-C-TE has been in frequent contact with SCHWARTZBERG and information, regarding SCHWARTZBERG's contemplated legal moves in this case and SCHWARTZBERG's dealings with press contacts has been discreetly passed on to AUSA FANNING and Assistant District Attorney FRANK ROGERS, New York County, who has a case pending against KONIGSBERG in New York County.
