Surveillances have further indicated that the whereabouts of BONANNO during part of the period in March and April, 1963, were not known and inquiry by other offices has failed to establish his whereabouts during this period.

PX T-1 has advised that BONANNO spends the majority of time at his home, when in Tucson, Arizona, and stated that nothing has ever come to his attention which would indicate that BONANNO is, or has been, engaging in illegal activity of any type in the State of Arizona.

PX T-2 has advised that BONANNO has continued his interest in real estate transactions in the Tucson area, all of which appear to be legitimate. Informant has stated that BONANNO appears to be engaged in no illegal activity in the Tucson area.

PX T-3 has advised that BONANNO continues to make frequent visits to the home of his son, WILLIAM SALVATORE BONANNO, at Phoenix, Arizona, and to also make visits to the home of his daughter, CATHERINE GENOVESE, at San Mateo, California. Informant has no knowledge of other travel of BONANNO but has advised that BONANNO's whereabouts were not known during part of March and April, 1963.

Informant has stated that BONANNO appears to be engaging in no illegal activity in Arizona and to the best of his knowledge, has had no contacts by persons from out of the state in connection with any criminal activity.

Informant has stated that he has no knowledge of any organized criminal activity in the State of Arizona.
