Regional Coordinator [REDACTED] IRS, Dallas, [REDACTED]

As stated in referenced airtel, Dallas Division was discontinuing the investigation in this matter and upon receipt of information from auxiliary offices, closing report would be submitted.

On 7/25/63 PCI PHILIP STEIN advised that from information he has received, JOHN STONE and his associates have not been active or attempted to set up new office space for their bookmaking operations.

On 7/27/63 DL 185-C-TE advised that from a recent conversation between STONE and MILLER in which they were discussing their recent arrests by IRS agents at Dallas, they indicated that IRS overheard the conversation between STONE and "MAURICE" concerning the line. STONE did not further identify MAURICE other than that he was connected with the Dunes Hotel in Las Vegas, Nevada.

Informant also advised that STONE and MILLER are continuing their bookmaking operations but on a very limited basis and are only handling their business on a strictly "hand to hand" basis, meaning that they are meeting their

customers in person at various business establishments. Informant stated that they are not presently using any telephones in their business at the present time.

On July 9, 1963, MRS. ROSE MARY WESTBROOK, former wife of JOHN RICHARD WESTBROOK who has requested her identity be protected, advised that WESTBROOK had called her several days previously. She advised that during this conversation WESTBROOK mentioned that he had been in Las Vegas, Nevada, during the past month and had met STONE and MRS. STONE there. MRS. WESTBROOK was of the opinion that this trip was during the latter part of June, 1963.

The records of Southern Bell Telephone and Telegraph Company, Fort Lauderdale, Florida, were checked by IC ROBERT JOHN SCHAMAY on 6/4/63.

On 6/25/63, LA 4148-PC advised SA NEWTON E. YOST that he does not know STONE or WESTBROOK and their photographs are not familiar to him. LA 4148-PC is familiar with some gambling activities in the Los Angeles area.
