VILLA MODERNE ENTERPRISES IS LESTER KRUSE. OVERHEARD KRUSE AND OTHERS

DISCUSSING VILLA MODERNE. CG SIX FOUR FIVE SEVEN DASH C ADMITTED

THAT IT WAS POSSIBLE GIANCANA CONSIDERED HER AS HIS QUOTE GIRL END QUOTE

IN THAT SHE WAS SEVERELY ADMONISHED BY GIANCANA ON NUMEROUS

OCCASIONS FOR CONTACTING ANGELO FASEL. CITED AN EXAMPLE WHEREBY SHE

ATTEMPTED TO CALL IN A BET AT HORSEBOOK WHERE FASEL WAS EMPLOYED,

UNABLE TO REACH FASEL, ADVISED PERSON ON PHONE OF HER IDENTITY.

GIANCANA CONTACTED HER ONE HOUR LATER, ADVISED HER THAT HE HAD BEEN

TOLD OF HER CALL, HAD FASEL FIRED IMMEDIATELY FROM BOOK, AND GAVE

INSTRUCTIONS THAT FASEL WAS NOT TO BE ALLOWED ADMITTANCE INTO ANY

OF THE CICERO HORSEBOOKS. GIANCANA THEN TOLD INFORMANT THAT IF FASEL

WASN/T CAREFUL, HE WOULD HAVE BOTH HIS LEGS BROKEN. INFORMANT

WAS QUERIED RE HER KNOWLEDGE OF RIVER FOREST BANK ROBBERY, STATED

SHE WAS NOT AWARE OF IT, DENIED THAT FASEL COULD HAVE ANY PART OF IT.
