Enclosed herewith for Las Vegas is a copy of referenced San Diego airtel, which contained information pertinent to the Las Vegas Division, however, was inadvertently not furnished to Las Vegas at the time airtel was prepared.

SD 1064-C-TE was recontacted on 9/15/67 and he furnished the following information on La Cosa Nostra (LCN):

I. LOS ANGELES DIVISION

Informant advised that to date the polling of the individual members regarding the selection of NICK LICATA as the new boss for the Los Angeles family has not been completed. He stated that he feels that this would be completed by the latter part of the following week. Informant advised that he had traveled to Los Angeles on 9/13/67 and had talked to JOHN ROSELLI. During this meeting with ROSELLI, ROSELLI indicated that he was quite worried over the action being taken regarding his citizenship.

he does not believe that it was to go to the extent that SINATRA would be punched, losing two teeth. He also indicated that he feels that SINATRA will go to the Caesar's Palace since this establishment does have family interests.

Informant advised that he had recently learned through FRANK LA PORTE of the Chicago family that the Chicago family feels that the government is in back of HUGHES in buying the hotels in Las Vegas. He stated that it is the Chicago family's feeling that this is an effort to remove family interests from the hotels in Las Vegas so as to eliminate steady income.

IV. CHICAGO DIVISION

In addition to the above, [redacted] was in San Diego 9/10-13/67 in connection with a Grand Jury subpoena. During his stay in San Diego, [redacted] stayed at the Hanalei Hotel. [redacted] departed San Diego 9/13/67 en route to Linden, California, to stay with a sister, planning to return to San Diego the week of 9/18/67 to be with his girlfriend who has also be subpoenaed to testify before a Federal Grand Jury. [redacted] is concerned over his girlfriend testifying because he does not know what she will say.

V. DETROIT DIVISION

Informant advised that he had learned from ROSELLI that TONY ZERILLI had been in Palm Springs in August and made an attempt to contact ROSELLI. ROSELLI stated that he was not available to ZERILLI. Informant advised that ROSELLI indicated that he would not assist the Detroit family in obtaining first-class entertainers for the New Frontier Hotel and indicated that he was going to teach the younger generation a lesson.

VI. SACRAMENTO DIVISION

Informant advised that he had learned that JIMMIE FRATIANNIO was currently living with his girlfriend, JEAN BOUDL, in Napa, California. He stated that he had heard that FRATIANNIO had moved out of his house, however, could not state exactly what date.
