On 11/17/64, photographs were taken in the vicinity of Marinan Funeral Home, Jersey City, New Jersey, where subject was being waked. Several photographs were forwarded to the Miami Office since representatives of the Central Investigation Bureau (CIB) New York City Police Department and of the Waterfront Commission of New York Harbor made separate tentative identification of an individual in these photographs as being identical with EDWARD J. MC GRATH, Miami top hood.

By letter dated 1/27/65, Miami advised that a review of these photographs failed to determine positively that the individual in the photographs was MC GRATH, but Miami noted that "it does bear a slight resemblance." It is also noted that in the details of this report MM 986-C-TE, under symbol NY T-2, indicated that he had heard that MC GRATH had attended the funeral of NOONAN.

In view of the death of subject, this case is being closed with the submission of instant report.
