Confidential Informant T-3 on January 4, 1954, furnished substantially the same information as to the leadership of the Mafia in the Pittston area.

On April 23, 1958, Confidential Informant T-3 advised SA NOAH R. BASS that DOMINIC ALAIMO and JAMES OSTICCO are controlled by RUSSELL BUFALINO and are the "strongarm men" of the Mafia, although ALAIMO is not too active as a strongarm man.

On June 19, 1958, Confidential Informant T-9 advised that he would consider ALAIMO as the number one man under RUSSELL BUFALINO in the organization, even though ALAIMO does not associate socially with BUFALINO. He further advised that he knew of no present illegal activities of the subject.

On March 28, 1958, Confidential Informant Till advised SA FRANK W. MULDERIG he is convinced the purpose of the meeting at Apalachin, N. Y., on November 14, 1957, at the home of JOSEPH BARBARA was to take control of the women's garment industry. He said that LEONARD BLANDINA, who is a partner of ANGELO SCIANDRA in S & B Sewing Machine Company which is located in the plant owned by SCIANDRA on South Main Street, Pittston, Pa., told him that was the purpose of the meeting, and further, that on other occasions, he heard NICK ALAIMO and SAMMY DI BELLA, associates of RUSSELL BUFALINO, discussing the purpose of the meeting and they, too, in their conversation said that was the purpose of the meeting.

T-11 said the only one who told him directly the purpose of the meeting was LEONARD BLANDINA, but on three other occasions he overheard conversations indicating the above was the purpose of the meeting, and BLANDINA did not institute or commence such conversations but they were conversations by ALAIMO and DI BELLA.
