ROSSELLI has been residing Los Angeles during past week. He left Los Angeles for Las Vegas on Western Airlines Flight 30 at 9:15 p.m. on Thursday, 10/10/63.

On 10/10/63 LA 4396-C* advised ROSSELLI told an individual named PETE (LNU) that he would meet him at the Friars Club in Beverly Hills at 3:30 p.m. on 10/10/63. However, LA 4268-C advised that between 3:00 p.m. and 4:15 p.m. on 10/10/63 he did not observe ROSSELLI at the Friars Club.

LA 4268-C advised that on 10/8/63 ROSSELLI was at the Friars Club in the afternoon and was playing cards.

On 10/9/63, according to LA 4268-C, ROSSELLI was at the Friars Club and was in conference with MORRIE SUESS, a motion picture director, and producer who has spent most of the past several years in Italy and who had just returned from a trip to Italy. SUESS and ROSSELLI left the club together at approximately 4:30 p.m.
