(S) You should follow with the Bundesamt fuer Verfassungsschutz (BfV) in its efforts to locate and interview Helmut Hubert Muench and Dirk Kunert concerning the basis and preparation of the above two articles.

British Security Service, MI-5, has furnished the following information regarding Kunert, which is classified "Secret." Kunert was born 1941 and formerly resided at 2 Hamburg-Fahle, Brosestrasse, 75, West Germany. He was reported to have previously studied law and history at Hamburg University and to have been studying in December, 1963, at the University of Dallas, Dallas, Texas, where he was also a research assistant in the Department of History. MI-5 has advised that Kunert has strong "right-wing" views. (S)

Dallas, which has been previously furnished information regarding Kunert, is being furnished copy of referenced Legat, Bonn, airtel. Dallas should make a discreet inquiry to determine if Kunert still at the University of Dallas, and, if not, his possible whereabouts. Furnish Bureau promptly with results of this inquiry. Dallas should not interview Kunert in this matter without prior Bureau authority.

NOTE: Articles in the DNZSZ of 11-29-63 related to General Edwin A. Walker, one article being a report of a transatlantic telephone interview with Walker by a representative of that paper and the second related to statement that Oswald made an attempt on the *General* ~~subject's~~ life early in the Summer of 1963, and following arrest he was released by order of Attorney General Robert Kennedy. The above publication has been identified as an extreme right-wing publication by the [BfV]. The Bureau learned from Marina Oswald [CS] on 12-3-63 of Oswald's attempt on Walker's life in April, 1963, which is several days after the article appeared in Germany. The Bureau desires to determine the basis for the allegations in the German newspaper. The [BfV] believes that Muench was probably the [CS] author of the 2 articles above and was in the U.S. some time before 11-22-63 conducting interviews and research for the DNZSZ. Legat, [CS] Bonn, advises that the [BfV] is obtaining original copies of the DNZSZ issue 11-29-63 wherein the 2 articles appear. Dallas being instructed to check whereabouts of Kunert who was supposed to have returned to West Germany on April 1, but this not yet verified. Kunert reportedly a German student studying at the University of Dallas and a contributor to DNZSZ. Dallas not to interview Kunert if he is still at University of Dallas since possibility he not involved in preparation of articles. If Muench in interview by [CS] [BfV] implicates Kunert in the articles and Kunert is still in the U.S., consideration will then be given to interviewing him. Bufiles contain no identifiable derogatory info re Muench.

His articles in "L'Express" have been received from Legat, Paris, translated and copies thereof forwarded to the President's Commission. No active investigation being conducted on Buchanan, but information re his presence in the U. S. being furnished Legat for reference to the DST which wants to know if Buchanan's articles were or were not written in Paris. If information shows articles prepared in Paris without visit to U. S. to get facts, Legat says DST may be able to take some discreet action to discredit or neutralize Buchanan. Answers to Legat letters held up pending receipt of translations of Buchanan's articles received in Paris 3-20-64 letter and of articles in "Die Welt" 3-17-64 and 3-19-64 which could be furnished to Legat, Paris, in one letter. Legat, Paris, also furnishing DST appropriate background information re Buchanan. Baltimore, Dallas, Miami, and WFO also being furnished copies of translations of Buchanan's articles and "Die Welt" items 3/17 and 3/19/64 for information by separate communication. Above offices being requested to make no inquiry, but to furnish any available information re Buchanan's visit for transmittal to Legat, Paris.

ReNYairtel 4-1-64 setting forth allegation of Theodore Lee received from NY 3948-C. Allegation set forth in reairtel is similar to allegation made by Mark Lane who is known to your office in testimony before the President's Commission alleging that a week prior to the assassination of President Kennedy a meeting took place at the Carousel Club in Dallas, Texas, which was attended by Mr. Bernard Weissman, Dallas Police Officer J. D. Yipsett, and Jack Ruby. Investigation has developed no information indicating that such a meeting ever took place or that such a meeting was ever likely.

In view of the nature and Commission's interest in above allegation, additional efforts should be made to reinterview Lee specifically concerning statements set forth in reairtel. While protection of your informant should be born in mind, if cooperative, Lee should be pinned down to specifics. If uncooperative, we should at least give him opportunity to put up or shut up in view of his past position and influence as head of Fair Play for Cuba Committee (FPCC).

Attached for your assistance are two copies of a Dallas report dated 3-11-64 re subject. The copy of the report not having the cover pages should be furnished the RCMP for its interest. Attached report constitutes a summary of investigation concerning Albert Osborne, also known as John Howard Bowen. On page 16 of this report, data is set out concerning a Canadian passport #4-347367 issued to Albert Osborne in June, 1963, and Canadian passport #5-605377 issued to Osborne on 10-10-63 as well as a reference to Osborne's alleged former service in the Canadian Armed Forces.

In transmitting the attached report, you should point out the foregoing data appearing on page 16 to RCMP. Also advise RCMP for its information that Osborne's dual identity has been brought to the attention of our INS and, in particular, that Osborne has been in the U.S. since 1914 except for the years 1916 through 1919 which he spent in Canada and has never become a U.S. naturalized citizen. During the last twenty years, Osborne has spent the greater part of his time in Mexico where he operates a Baptist Mission. He is more or less a self-ordained Baptist minister. RCMP may also be interested to learn we have advised the U.S. Chief Postal Inspector that Osborne/Bowen has been receiving contributions for his mission in Mexico at a Laredo, Texas, address, and thereafter these contributions are forwarded to Osborne/Bowen in Mexico.

The above data should be of interest to the RCMP as the possibility exists that INS may eject Osborne/Bowen from the U.S. and bar him from further entry. There is also a possibility he may be asked to leave Mexico. Therefore, he may have to return to Canada where he claims to be a naturalized citizen.

A copy of attached Dallas report 3-11-64 is also being furnished to Legat, Mexico, for its information in view of possible action INS or the Chief Postal Inspector may take against Osborne.

Rebulet 3-11-64 transmitting Dallas report 3-11-64 wherein Dallas desired to be advised if additional investigation should be conducted to establish Osborne's activities and movements in recent years. For Dallas' information, the Dallas report 3-11-64 was furnished to the Presidential Commission on 3-30-64 and the Commission was advised that no additional investigation concerning Osborne/Bowen would be conducted unless a specific request was received from the Commission.

NOTE: A man named John Bowen sat next to the subject during the bus trip from Texas to Mexico City on 9-26, 27-63. Bowen has been identified as Albert Osborne, born 11-12-38 in Grimsby, England. He is a self-ordained Baptist minister who runs a mission in Mexico and appears to be a con man. He was interviewed in Nashville 3-3-64 at which time he admitted furnishing false info as to his identity and denied any knowledge of Oswald or being a passenger on the above bus. We have conducted considerable investigation and have established that Osborne was sitting next to the subject on the bus on the above-mentioned trip and to pursue this point further will not furnish us any additional productive data. It does not appear that Osborne has any personal knowledge relating to Oswald or any connection with Oswald. His hesitancy and vagueness during interview is attributable to the fact that he is a con man operating a missionary in Texmelucan and is soliciting funds for this missionary under the name of Osborne and Bowen. He recently advised one of the contributors that Bowen had been his associate in the operation of the mission and had died and so as not to lose money Osborne arranged with banking authorities for payments in both the name of Osborne and Bowen. By letter 3-30-64 we furnished the Commission the copy of the Dallas report and suggested it may desire to subpoena Osborne and place him under oath in view of the fact that he has continually lied to us. We also advised INS and the Chief Postal Inspector by letters 3-30-64 as indicated in the outgoing. Legat, Ottawa, had been requested to obtain all data available concerning Osborne from RCMP. RCMP had little data of value and requested additional data of an identifying nature from us. There is no further need to continue the Osborne aspect of this investigation in that we have resolved he has no connection with Oswald.

RCMP inquiry negative but they did furnish the Legat with a photo album of individuals participating in a "walk for Peace" in Montreal on June 7 and 8, 1963. Mr. Tremblay stated that the individual he believed was Oswald was seen by him on the same day he saw six other individuals handing out "Cuba" literature. He has identified by photographs two of the individuals as passing out literature on the day in question. According to RCMP, however, Tremblay could not point out in these photos the person who gave him the pamphlet and who he believes to have been Oswald.] We know that Oswald was at work in New Orleans on June 7, 1963, from time punch cards of the William B. Reilly Company, New Orleans. Commission will be furnished letterhead memorandum from Legat on receipt of Bureau. [<]
