WITH REGARD TO YOUR REPORT OF YOUR INTERVIEWS ON 8 AND 11 APRIL 1977 WITH FELIX ZABALA MAS AND TO YOUR ORAL QUESTIONS TO US CONCERNING STATEMENTS MADE BY HIM ABOUT VECIANA IN THOSE INTERVIEWS, THIS AGENCY HAS REVIEWED ITS FILE ON ANTONIO CARLOS VECIANA BLANCH. AS STATED TO YOU ORALLY AT OUR MEETING ON 13 APRIL 1977, THIS AGENCY HAS NEVER HAD A CONTRACTUAL RELATIONSHIP WITH VECIANA. ACCORDING TO OUR RECORDS, VECIANA CONTACTED THIS AGENCY ON THREE OCCASIONS TO DISCUSS HIS PLANS TO ASSASSINATE FIDEL CASTRO. ON THESE OCCASIONS, OUR OFFICERS LISTENED TO VECIANA BUT EXPRESSED NO INTEREST IN AND OFFERED NO ENCOURAGEMENT TO HIM AND NEVER RECONTACTED HIM ON THIS MATTER. THESE CONTACTS
