THE FOLLOWING IS SINGULAR IN NATURE AND NOT
TO BE DISSEMINATED OUTSIDE THE FBI:

On 9/5/67, NO 1457-C-TE advised that the MARCELLO brothers' long-time friend, NELSON BARRIOS, and his wife, JUNE, have opened a new restaurant on the Westbank known as Alfredo's. The restaurant opened on 8/30/67, and is a very plush restaurant.

Informant stated that the BARRIOS' had a pre-opening party at the restaurant, and source understood that numerous hoodlums including CARLOS MARCELLO, attended this party. BARRIOS, in 1966-67, was operated under the TECIP in the New Orleans Division with negative results. In 1966, informants and other sources of information had stated that BARRIOS appeared to be the primary gambling front for CARLOS MARCELLO. It is not known under what conditions BARRIOS became associated originally with the MARCELLOS. Sources have stated that in the past, he has been a legitimate businessman and has accumulated considerable wealth.

On 12/27/71, NO 2536-PC advised SA RICK P. BAKEN that the Half Shell (Alfredo's) was presently an active poker location, housing 15 tables with a \$100 minimum for play.

New Orleans has a pending inactive IGB case (NO 182-301) concerning the Half Shell Bar.

On 4/2/72, captioned business sustained extensive fire damage wherein the entire interior portion of the restaurant was destroyed.

On 4/19/72, the owner, NELSON BARRIOS, on a pretext contact, advised that he was in the process of repairing the restaurant, and estimated that he may be able to reopen for business sometime within the next three or four months.
