This investigation consisted mainly of obtaining long distance telephone tolls for subject's home and business phones. The investigation disclosed that the majority of the telephone calls were to the New Orleans, Louisiana, area, and many were made to the Elmwood Plantation Restaurant which is operated by VINCENT MARCELLO, whose brother is CARLOS MAR-CELLO, LCN figure in the New Orleans area.
