Will maintain contact with Gambling Squad, Dallas Police Department, and confidential informants to report results of investigation to identify subscribers to telephone numbers called from telephones to the subject. Report results of any prosecution of subject on criminal gambling charges.

For information Oklahoma City, subject is a well known bookie and gambler who has been operating in the Dallas area for a number of years.

On 10/29/70, DL 275-C-TE advised SA WILLIAM B. HOLLOMAN stated that on 10/28/70, while at the Chateaubriand Restaurant, he was introduced to KIRKSEY MC CORD NIX and his young brother by R. D. MATHEWS, a local gambler and bookmaker. NIX is a close associate of MATHEWS who is a known burglar and hoodlum. He indicated that these were the same individuals who had dinner with ISADORE MILLER and LEONARD BURNETT, another known hoodlum, gambler and associate of R. D. MATHEWS.
